KEYNOTE SPEAKERS

Deborah Fein, PhD is a neuropsychologist and Professor of Psychology and Pediatrics at UConn and has published more than 150 articles and chapters on autism spectrum disorder (ASD). Her major contributions span a number of areas, including characterizing children who show optimal outcomes after diagnosis and treatment for autism, screening to promote early detection of autism and developing theoretical models of autism. She edited a volume, *The Neuropsychology of Autism* in 2011, is a co-author of the Modified Checklist for Autism in Toddlers (M-CHAT), and the M-CHAT, Revised. She also published a book for educators on adapting classroom strategies for children with autism (*Autism in Your Classroom*), and her newest book, *Activity Kit for Babies and Toddlers at Risk* for parents was first place winner of the *American Journal of Nursing* Book of the Year Award, Child Health Category in 2016. She is currently developing a website that will be available for free to parents, to teach them principles of behavioural teaching and stimulating attachment.

Thyde Dumont-Mathieu, MD, MPH is a Board Certified Developmental-Behavioral Pediatrician who has been in practice for over fourteen years. Her clinical subspecialty is in ASD. Her research interests include ASD, Health Services and Health Equity. She has been working with Dr. Deborah Fein on validation and revision of the M-CHAT since 2003. She collaborates with Dr. Marcella Nunez Smith, an internist and the Executive Director of the Equity Research and Innovation Center, at Yale since 2009. She is part of an Autism Research Collaborative at CT Children’s Medical Center and UConn. Her current research study, *Strategies to Promote Culturally Effective Screening, Referral and Service Provision in Primary Care Practices and Birth to Three Programs*, funded by the CT Health Foundation, is a collaborative effort between CT Children’s Medical Center and the state’s Early Intervention Program.

Tere Ramos-Dunne, Esq. is an education, children and civil rights attorney working at the MA Law Reform Institute, MA’s poverty law center, to assert the rights of limited English proficient (LEP) families across the state. Tere’s work focuses on issues related to children who have disabilities and who are also limited English proficient. Prior to MLRI, she worked as an attorney at the Disability Law Center (DLC), focusing on special education issues related to the Hispanic community across Massachusetts. Prior to joining DLC, Tere was the executive director of Special Education Advocates, a special education and disability advocacy focused on underserved LEP communities. Tere is currently serving appointments to the MA Board of Social Workers, the MA Autism Commission education sub-committee, and the MA SJC’s Access to Justice Committee’s sub-committee on administrative agencies. She is also the Chair of the MA Department of Education’s Special Education Advisory Committee.
